The mission of Annie's Project-Education for Farm Women (APEFW) is to empower women in agriculture to be successful through education, networks, and resources. APEFW conducts training for facilitators who, in turn, deliver Annie's Project classes using the Annie's Project Methodology which means small groups; safe, dynamic, and interactive class environment, vetted presenters, (Continued on Schedule O, Statement 2)

Facilitator Training and Program Delivery: Eight training programs adding 86 facilitators, who in turn conducted 44 Annie's Project Programs in 20 states reaching 519 farm women. The Pandemic had considerable impact on the method of delivery which is usually in small groups. APEFW moved to online delivery for both training and program delivery to farm women. APEFW works with a third party evaluator, Research Institute for Studies in Education, Iowa State University (RISE) to provide pre and post evaluations documenting program impact. The results show Annie's Project risk management courses were effective in achieving the goal of improving women's knowledge in all five areas of agricultural risk management: financial, human resource, legal, marketing and production. According to the post evaluation the top three areas of interest were marketing, estate planning and basic financial documents. The full pre and post reports can be found on the Anniesproject.org website. Another project, Rural Leadership Academy, was also worked on but delayed by the pandemic. The assessment report defining rural women's habits and needs in the area of leadership will be published in 2022. While waiting for the pandemic to ease, the board implemented elements of leadership in their board and committee structure. Two new online formats were added in 2022 which were "Heard It (Continued on Schedule O, Statement 3)

In 2022 Annie's Project worked under a grant through the USDA, "Mitigating Risk Across Common Barriers to Profitability" Project Number: 14387. As a result of pandemic protocols, in-person training and program delivery for parts of the program had to be modified for online delivery. A partner in delivery was able to hold a meeting in April of 2021 where 175 participated in a "barn" meeting and/or by followup phone meetings. Approximately 60% of the contacts were Amish. The online delivery part of the program was titled "Know Your Numbers, Know Your Options". All materials were reorganized and delivered online in March of 2022 for Northeastern states. The grant ended March 31, 2022. Online delivery programs are posted to the Annie's Project YouTube and are available to the public.
